Empower Youth Every day in the United States, youth experience exploitation in many different forms, from bullying to trafficking. iEmpathize is committed to equipping youth to stay safe from exploitation. iEmpathize is also committed to equipping professionals who work with youth to know how to work preventatively with youth and to effectively recognize and respond to signs of exploitation. The Empower Youth Program achieves both aims. It is a curriculum that addresses exploitation prevention from two angles: 1) empowering vulnerable youth with strengths-based, protective strategies and 2) empowering youth who may be choosing exploitative behaviors to instead choose empathy. The program, which consists of five lessons, is designed to be facilitated by adults who already have a professional relationship with youth, such as in a classroom, an after-school youth program, a juvenile corrections facility, a counseling or therapy environment, a faith community, and etc. Each lesson features media that the youth will watch, activities to enhance their learning, and questions to prompt group discussion. In 2015, we released the program officially. During 2015, the program was ordered by 56 facilities, including schools, juvenile justice centers, faith communities, women's and youth service organizations, etc. in 12 states. In addition to the hundreds of youth impacted by The Empower Youth Program, iEmpathize trained 862 youth practitioners, 345 community members, and more than 1300 youth through in-person events we facilitated.

Empower Universities University students are often unaware of the ways their lives intersect with exploitation and human trafficking. Igniting empathy and empowering our future leaders with an effective response to exploitation can generate the cultural shifts necessary to end the issue of child exploitation. Our University impact in 2015 included Empathy Week, internships, and community outreach. During Empathy Week, hundreds of students at three different campuses - the University of California, L.A., the University of Colorado, and the University of Northern Colorado - experienced a week-long series of events designed to educate and inspire university students to actively engage the issue of child exploitation. In 2015, we also surpassed the mark of fifty interns who have received college credit from internships with iEmpathize. In addition to serving students, our engagement on university campuses connects us to local community members through our community forums and film and talk events. Also during 2015, we redesigned our Exhibit, renaming it The Apathy Effect. The multi-media exhibit and empowerment program is geared to ignite empathy and educate and empower participants with a response to issues of exploitation. The multimedia journey is told through original film, photography, and artifacts with self-guided or interactive tours adding to the experience. The Apathy Effect Exhibit will debut and tour in 2016.

Empower Adults In 2015 we also continued to promote our other empowerment programs in three different areas. First, we completed Phase II of our trucking industry training materials (distributed via partnership with Truckers Against Trafficking, an organization which empowers the trucking industry to engage in issues of child exploitation). These new materials feature diversified training and further expansion of our established education content for trucking and related industries, along with our touring mobile exhibit, the Freedom Driver's Project. In 2015, the Freedom Driver's Project was presented in 19 states at 45 events, and 9,100 people walked through. Second, for our Empower Oil Communities programming, we released a new version of our BOOM documentary as a pop-up training video for the oil industry. Our Empower Oil work was presented at the Nobel Peace Prize Program in March. Third, for our Survivor Program, we advanced in progress on the post-production phase of our documentary Be Relentless. Be Relentless follows mother, survivor, and ultra-athlete Norma Bastidas on the world's longest triathlon. The film, scheduled for release in 2017, will serve as a platform to educate and engage the public, industry leaders, and legislative influencers on the under-recognized issue of child exploitation in order to inspire a binational response to eradicate the victimization of children. The film's proceeds will benefit iEmpathize's ongoing prevention efforts as well as projects that empower and reintegrate fierce survivors like Norma.
