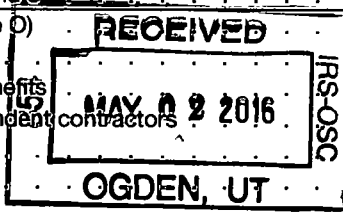

The bulk of these expenses are described. The largest amount of these expenses are the direct result of program expenses. Mission trip expenses include a total of \$59,324. Most receipts can account for this, such as those that come from business enterprises like hotels, gas receipts, stores that may exist, some restaurant and other transportation entities. Some are not available or accountable for such as direct payments to drivers for 4x4 travel, cash requirements from government officials at places such as customs at airports, direct cash blessings to African associates, and small business entities in third world Africa. Other expenses include: 1) air travel \$5,290, 2) evangelism and other equipment supplies \$8,597, 3) communications \$3,456, seemingly large number, but necessary considering the scope of our ministry and the fact many live in the bush where direct internet connections are not readily available, 4) Mission travel documents \$602, and finally a larger amount of money was directed toward 5) humanitarian aid of \$4,368. This number differs from the program expenses because it does not take into consideration medicine costs or the delivery of those items to the villages of interest. This figure is separate from the mission trip expense figure, which does include medicine expenses and delivery costs.

**Part II**

**Line numbers**

Line numbers 22-27 differ slightly from the end of year numbers noted in 2014. The reason for this is the completion of the effect of a \$620 accounting error which was committed in 2013. This error should not effect further returns. The \$3 change on line 20 reflects the effects of rounding to the nearest dollar and has no real effect on reporting. Thank you.
