THE HOMES FOR HEROES CHARITABLE FOUNDATION'S MISSION IS TO ASSIST THOSE HEROES WHO ARE IN DIRE HOUSING NEEDS. TYPICALLY, THIS MEANS PAYING PAST DUE AMOUNTS TO AVOID EVICTION OR FORECLOSURE, OR PROVIDE DEPOSITS AND FIRST AND LAST MONTH'S RENT TO GET PEOPLE OUT OF HOMELESSNESS. WE ALSO TRY TO ASSIST THOSE IN NEED OF SERIOUS REPAIRS, BUT THAT REALLY DEPENDS ON THE TALENT WE HAVE ON THE GROUND THROUGH OUR NETWORK NEAR THE SUBJECT PROPERTY. IN ADDITION TO CASH ASSISTANCE WE NEGOTIATED THOUSANDS OF DOLLARS IN VALUE, IN DONATED SERVICES AND "IN KIND" DONATIONS FOR DESPERATELY NEEDED HOME REPAIRS. IN 2015, THE FOUNDATION ASSISTED 130 HEROES. OF THAT NUMBER, 90% WERE TO BE EVICTED AND WOULD BE HOMELESS. WE ARE TRACK TO DOUBLE THAT ASSISTANCE IN 2016. NINETY-FIVE PERCENT OF REQUESTS ARE SERVICE CONNECTED DISABLED VETERANS.
