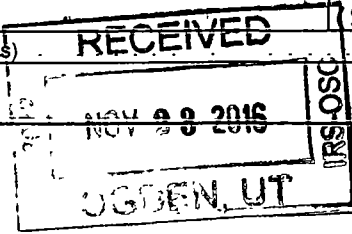

Legacy Project is empowering Haiti, Peru, Uganda, and South Africa through education, job creation, community development, leadership training, and more. Seven school classrooms that will serve hundreds of children in these four countries is being built in environments that are protected. They will allow future generations the same opportunity to break the cycle of extreme poverty.

To rescue orphans by having them sponsored by families through monthly amounts paid for supplies and care for the orphans. We have child sponsorship programs in 10 diferent communities, 5 different countries in order to improve the lives of orphans and vulnerable children. In 2015, this program served around 800 children in various ways including food, clothing, shelter, water, education, health care, counseling, recreation, and more.

4c (Code _____) (Expenses \$ **30,795.** including grants of \$ **30,795.**) (Revenue \$ **85,286.**)

Ferrier Village - an anti-trafficking initiative of help one now in northeastern haiti - is a refuge for orphaned children who have been rescued from traffickers, or are at a high risk of being trafficked. It is a place where these children will be cared for and restored to physical, mental, emotional, and spiritual health. In 2015, we rescued 12 orphans, holistically cared for 37 children, built and opened one preschool, started 1 garden, and 20 Haitians were employed to operate the village.
