Help Animals India gave grants to Visakha Society for Protection and Care of Animals (VSPCA) India to assist with a myriad of innovative and lifesaving projects After the devastating Cyclone Hudhud in Octoer 2014, outreach for animal rescue and shelter restoration of cattle shed, workers room, aviary, ABC (animal birth control) sheds and Laboratory room All trees need replanting Street dogs - target of zero rabies in the area was reached and a full-time ABC program continued Temple calves grant helps VSPCA rescue live calves which are offered to the temple for illegal killing Star tortoises , Olive Ridley sea turtle rescue and rehabilitation of this endangered species including wages for a night watchman SOS daily expenses, wages for emergency animal rescue personnel Special needs facility for this facility is for old, blind and disabled dogs , rescue illegally-used parrots ABC for cats and stray cat rescue and stopping poaching Purchase of cat traps Cat and dog protection program with feeding of street dogs Vegan meals with the Kindness Mobile Restaurant provides vegan meals and blankets to the very poor who also care for street dogs Water bowls for the street animals Operational expenses (including vet salaries) as the only animal shelter/hospital in the region, the grant has allowed VSPCA to continue to care for an increasing number of animals of more than 1800 animals receiving life-time care, daily emergency animal rescues and mobile rescue facilities Adoption program - grant supports wages for team to manage awareness/education/adoption program Plastic cow grant for medicines required for surgery to remove plastic from stomachs of cows

Help Animals India gave Varanasi for Animals funds for the construction of an animal hospital/shelter/clinic in Varanasi , the first of its kind in this ancient city The facility has Kennels for dogs, Operation theatre, Reception room and a Staff room with toilet and bath facility Additionally 240 female dogs were sterilized Surgical equipment including a gas anesthesia machine was bought and a manager and two assistants were compensated for an entire year

Animal Nepal received \$ 36000 from Help Animals India in 2015 Nepal was badly hit by a earthquake at the first quarter of 2015 and the majority of the funds use for earthquake related activtites Many people and countless animals were affected during that time A survey learns that close to 150 000 birds, 8000 buffaloes and cows and 14,500 pigs and goats died The number has however gone up after the strong aftershock on May 12 Animal Nepal mobilize three teams to reach out to injured livestock in Kathmandu, Lalitpur, Dhading, Rasuwa, Nuwakot and Sindhupalchowk districts A total of 900 animals were benefitted, including 500 working equines plus 175 farm animals in Lalitpur, 152 in Dhading, 54 in Sindhupalchowk, 22 in Kathmandu, 13 in Rasuwa, 6 in Nuwakot and 3 in Bhaktapur District Animal Nepal together with World Vets and JGI Nepal manage to handle various cases in Dhading, Sindhupalchowk, Rasuwa and Nuwakot The teams were shocked by the severity of the injuries They came across broken spines and broken limbs, and treated vamous cases of pneumonia and diarrhea Animal Nepal mainly focused in the treatment of canines but after the disaster they went out of their comfort zone to help all the injured animals as stray dogs suffered relatively less casualties compared to the farm animals The livestock are mostly kept inside the farm, tied with a rope, the reason for which they were the one to get injured The grant provided by Help Animal India enable our team to reach out countless needy animals Part of the grant also been used for Godavari Donkey Sanctuary, a home of rescued working equine
