	In April 2013, Daily Hope Ministries launched its Pastor Ricks Daily Hope audio bible teaching program in the United States in order to spread the Gospel and share the hope we have in Christ. Since then, Daily Hope has also developed an international format for its audio broadcast which can now be heard in the African countries of Rwanda, Uganda, Kenya and now Zambia, as well as in other countries such as Ireland and South Korea. Daily Hope also began supporting the distribution of its audio broadcast on solar powered radios within refugee camps in South Sudan. Additionally, Daily Hope has created an audio broadcast program for a series of online and podcast platforms and actively engages on a variety of social media outlets to reach millions with message of hope and the good news of Jesus Christ. Daily Hope was recognized by National Religious Broadcasters (NRB) to receive the Billy Graham Award for Excellence in Christian Communications, which is presented each year as described by the NRB to a Christian organization that effectively and creatively uses multiple electronic media technologies in fulfillment of its mission, while maintaining fidelity to the message of love, redemption, and hope found in the Holy Scriptures.
