

At our retreat center (Wonderwell) we offered training in Tibetan Buddhism through 1) Buddhist meditation retreats that ranged from one weekend to one month, 2) a weekly meeting of meditation and Buddhist study, 3) "Dharma Sunday" - a monthly all day program of meditation and Buddhist study, and 4) the "margha program" - a formal, multi-year study program in Buddhist meditation with over 100 students. These were all overseen by "Lamas" (teachers/ministers) trained in the Tibetan Buddhist tradition. We also did several other retreats at other locations.
