

Part 1, line 8: Other Revenue. This includes payments from our Peruvian partner which has 2 employees in the U.S. However, the Peruvian organization had difficulty setting up payroll in the U.S. (now resolved). In the meantime Awamaki U.S. paid the two employees and the Peruvian partner reimbursed us. Other Revenue also includes miscellaneous revenue such as refunds received.

Line 10, grants paid out: \$100 paid to our education partner Kuska school, a not-for-profit school in Peru. The remainder paid to Asocacion Civil Awamaki, our partner organization in Peru creating women's empowerment opportunities there.

Line 16, other expenses. This includes printing, bank fees, government registrations, travel and supplies.
