Health and education November 2015, Global helped launch the "Continuing Education for Adults with Down Syndrome & Improved Cognitive Outcomes" classes and research at the University of Denver with the support of both the University of Denver and Colorado State University In support of this program, Global provided a grant of \$136,848 to the University of Denver Global also held 4 days of educational seminars in 2015 as part of Global's Educational Series The Educational Series convenes nationally and internationally recognized Down syndrome experts in Colorado for two full days The first day is designed for professionals who impact the lives of individuals with Down Syndrome and the second day is dedicated to parents, caregivers and individuals with Down Syndrome Topics focus on accurate and updated medical, educational and therapeutic best practices The Educational Series has featured leaders in the field of Down Syndrome care and research, including education specialists, pediatricians, scientists, physical therapists and speech language pathologists Since 2006, the Educational Series has provided empowering and, sometimes life-changing, educational support to more than 3,400 individuals and families Our results have been meaningful and our reach impactful It is our goal to continually improve upon our work, educate and serve our community at the highest level Finally, Global issued educational grants in the total amount of \$75,300 to local and national Down Syndrome organizations and \$25,000 to the Alzheimer's Association in 2015

Outreach The goal of Global's outreach programs is to provide the highest quality health oriented activities and education to people with Down Syndrome and their families Global staff learn from programs launched by other organizations, and in turn, encourage and help others to launch similar programs Additionally, these programs help ensure people with Down syndrome have the opportunity to have fun, gain confidence, excel and reach their potential which effects many areas of their lives In support of these goals, Global hosts Dare to Play camps Football, Cheer, Soccer, several dance classes and an educational series all of which promote mental and physical wellness Moreover, Global conducts roundtables, workshops, and briefings on Alzheimer's disease-Down Syndrome research and advocacy All of the aforementioned programs are designed to help people with Down Syndrome dream big so they can not only meet, but exceed their expectations
