Currently, there are fewer than 400 approved treatments for 7000 rare diseases affecting more than 30 million Americans. The science exists for many of these diseases to be treated, however, treatments may never be developed because of roadblocks in the development process, such as a lack of investment and a challenging regulatory environment.
