Gosnell Project - In 2015, CLI developed policy papers and commentary on late-term abortion in the United States. The papers examined, among other topics, the medical, economic, and relational rationales cited as motives for late-term abortion, and the increasing survival rates for infants born prematurely as early as 22 weeks of gestation.
