 Research HIP conducts policy-focused, innovative, and strategic research that evaluates health impacts and inequities to support targeted campaigns and movements for social change In 2015, HIP completed fourteen such research projects including Health Impact Assessments across the country with more than twenty community, policy, academic, and government partners The projects were of relevance nationally and locally, and focused on topics such as policing practices, housing displacement, land-use planning, and evaluation of community-engagement practices in Health Impact Assessment An additional seven research projects also began in 2015

 Capacity building HIP provides training and technical assistance to build the capacity of impacted communities and their advocates, public agencies, and elected officials to take action on the social determinants of health and equity In 2015, HIP conducted 8 trainings and provided technical assistance to over 20 community organizations and government agencies across the country to build their capacity to conduct Health Impact Assessments and related projects HIP also built the capacity of community organizations to integrate a public-health approach in their organizing campaigns, and convened a national meeting linking criminal-justice and public-health advocates Finally, HIP led the Public Health and Equity Cohort, a leadership-development initiative to tackle the structural and institutional challenges facing local health-department practitioners who want to advance health-equity work

 Awareness building Through various communications strategies, HIP works to raise awareness of the relationships between health and social, economic, and environmental decisions, the ways in which public health can collaborate with other social-justice movements, tools such as Health Impact Assessment and Health in All Policies and the values that underpin these fields as ways to improve health and reduce inequities, and successes and impacts that using public-health research and framing can have in community-organizing campaigns In 2015, these strategies included presenting at seven conferences/networks, publishing 40 blog posts, earning over 25 media hits profiling our work, participating in four social-media campaigns highlighting our research, and sending out six organizational newsletters
