Innovators Robotics, Inc. is a nonprofit organization started in 2009 to provide science, technology, engineering, and math (STEM) opportunities to students in the Dayton area. The organization is run by a group of volunteers dedicated to inspiring students to pursue STEM related careers. We are a community organization that is not affiliated with any school, so we accept students from anywhere in the greater Dayton area. Innovators Robotics funds FIRST (For Inspiration and Recognition of Science and Technology) robotics teams for students of different age groups. This includes FIRST Robotics Competition (9th -- 12th grade), FIRST Tech Challenge (7th -- 12th grade), and FIRST Lego League (4th -- 8th grade) teams. The primary purpose for our organization is to provide STEM exploration and leadership opportunities for students as well as providing volunteer services for community educational outreach projects in the Dayton and surrounding areas. Students learn by working alongside adult mentors who volunteer to teach students the skills that the mentors use in their careers. The high school students also learn leadership skills by taking on important team lead positions and mentoring younger students in STEM projects. The robotics teams serve as a hook to get students interested in STEM, but we provide many more opportunities for the students to learn and grow outside of the robotics competitions. The teams generally spend about 4 months out of the year building their robots and attending competitions. The other 8 months are dedicated to educational outreach programs designed to encourage STEM interest and to create more STEM programs throughout Dayton. Every year the students teach STEM classes for summer camp students at the Kroc Center, run robotics camps for rookie FIRST Lego League teams, teach robotics to Boy Scouts, and talk to families about STEM at the National Museum of the United States Air Force Family Day events. We are also dedicated to helping start more robotics teams in Dayton and spent several months this summer mentoring a new FIRST Robotics Competition team starting in Dayton. This new Dayton team consists of students from Dayton Early College Academy (DECA) and Oakwood. We are proud to provide all these opportunities at no cost to the students. Overall, Innovators Robotics helps students develop new STEM and leadership skills by solving fun challenges through exploration, experiential learning, and teamwork.
