

All residents were served by case managers who assisted the residents with goal setting, problem solving an connecting with area resources. Also, during their stay at the Shelter, residents were counseled in the area of personal care, family living, financial responsibility, job interviewing, and employmnet. Thirty-nine (39) percent of Shelter residents left the program having both employment and housing.
