The PPD is shared with UN officials, national governments, and NGOs that use the data to advocate for fair treatment and release of the prisoners. This year, additional information such as judges and prisons was included in the PPD.

Mobile app technology - Provide new pathways for engagement in human rights advocacy through interactive tools (apps) that address access to needed information. A new component launched this year was to create capacity for app developers or people who have ideas for apps through an incubator approach. All apps supported by U4I aim to improve human rights.

Right to serve and protect program to provide support to strengthen civil society's understanding of political imprisonment and application of best practices if someone should become a political prisoner.
