Shelter equipment and fixtures--

FOTAS funded several important fixture and equipment items for the shelter which could not be purchased otherwise because
of county budget shortfalls. Most importantly, FOTAS funded the construction of a fenced and covered puppy play area which could
be sanitized after each play time to prevent the spread of deadly diseases such as parvo. Other important items purchased for the
shelter included a storage building for the storage of bulk dog and cat food, an autoclave for sterilizing instruments in the medical
clinic, a cat condo for display of adoptable cats in the lobby of the shelter, a dog wash tub with associated plumbing, as well as
several smaller items.

Transfers and foster care--

Due to over-crowding at the county animal shelter, FOTAS worked aggressively to transport as many adoptable animals as
possible to no-kill shelters. The transfer program includes an extensive network of volunteers who foster dogs until they are old
enough or healthy enough for transport. Also included in this program is medical treatment for heartworm positive dogs that
can be difficult to adopt and impossible to transfer. In 2015, FOTAS facilitated the transfer of 908 adoptable cats and dogs to
no-kill shelters.

Spay and neuter financial assistance program--

To reduce the number of unwanted animals euthanized at the county animal shelter, FOTAS funded spay and neuter surgeries for
599 dogs and cats in Aiken county in 2015. Spay and neuter assistance is a long-term program to eliminate pet overpopulation
which causes over-crowding and high euthanasia rates in the shelter.
