The vision of 1040i is to transform the lives of people in need by fighting pain and suffering in the most isolated places on our globe. The primary focus will be centered on health and education needs between 10 degrees and 40 degrees north of the equator spanning across North Africa and the Middle East.

Projects and Trips: This is 1040i's largest program. In 2015, 1040i conducted 2 trips to Cote d'Ivoire and provided medical services to the local people. The first trip used 5 surgeons and the 2nd trip utilized 1 surgeon using a mobile surgical unit. During the trips a total of 136 surgeries were performed including orthopedic, GYN procedures, Cleft palate repairs, hernias, tumor removals and cataracts. In addition to the procedures 189 glasses were given out as part of the eye care clinic. In conjunction with the medical team there was also a construction team who built a dormitory for a local middle school. A third trip was to Morocco where a team built a playground in a remote area near the Atlas mountains. It was the first ever of its kind. All three teams totaled 68 volunteers.

Rejoice Bilingual Academy: In 2015, 1040i enrolled students for first and second grade at its bilingual academy in Tanda, Cote d'Ivoire with the goal to change poverty through education. This academy instructs in both French and English from 1st grade through 12th grade, and upon graduation students will receive a dual American and Cote d'Ivoire diploma. 1040i owns the academy facilities, and the staffing and operations of the academy is managed by a private school in Oklahoma. The academy was completed and began operations in 2014. The academy will instruct in normal primary and secondary educational areas, as well as technology.

Part VI Item 12c: 1040i has a written policy regarding conflicts of interest, and it is distributed to all board members annually. At that time the board members disclose any conflicts of interest they have, or that they have none.

Part VI Item 15b: The 1040i board evaluates and sets salaries for the President and Secretary, which currently are the only two compensated individuals in the organization. The salaries are evaluated based upon duties, workload and performance, as well as consideration of compensation of similar positions at other not for profit entities.

Part XII Item 2b: The answer for this item was "no" because the audit of the 2015 financial statements has not been conducted yet.
