Touching Heart's mission is to inspire the next generation of compassionate leaders, one child at a time To date, over 1,000 school-age children and teens have experienced the true joy of giving, and have been inspired and empowered to make a difference in the world They have in turn, helped over 3,000 children in need Touching Heart inspires children to have a giving heart through two main programs Kids on a Mission events and our After School Programs

Kids On A Mission (KOAM) - Touching Heart coaches work with a leadership team of 3-5 children to select a cause, then plan and implement an event to raise funds to bring about positive change in the lives of children in need Touching Heart partners with carefully selected local causes that benefit local children and international orphanages Using a child-led, project-based learning curriculum developed by Touching Heart, these young leaders learn practical life and business skills including goal-setting, marketing, budgeting, public speaking and project management They experience the joy of working as a team together to help others in need, and most of them can't wait to do it again! Children in our programs see the impact of their efforts through photographs, letters, conference calls and video Touching Heart believes that children seeing the actual results of their giving actions is critical to inspiring children to continue to give Examples of Kids on a Mission events include a fashion show, Minecraft tournament, basketball and soccer tournaments, a princess tea party and a bake sale In 2015, over 400 kids participated in Kids on a Mission events, benefitting over 1,500 children locally and internationally from the funds raised and matched by Touching Heart

School Programs - Touching Heart's classes offer a unique experience for the children to think beyond themselves and consider how others live in less fortunate circumstances Participants take action to help others, and learn about the importance of compassion and giving They complete hands-on service projects such as preparing food for homeless shelters, making fleece scarves and blankets for children in need, and writing letters to orphans Elementary school classes consist of eight one hour sessions Touching Heart also offers a club for middle school students Launched in 2015 in Fairfax County Public Schools, Touching Heart's After School Program has grown quickly and received rave reviews from parents and students Over 75 children attended the classes in 2015 The service projects they completed helped over 400 children in need Touching Heart is expanding the program to more schools in 2016, adding classes in Loudon County, Montgomery County and launching a high school club

Touching Heart has had long-standing relationships with local organizations that help children in need including the Fairfax and Loudon County Foster Care Programs, Fairfax County Family Services, and Cornerstones Touching Heart also has conducted stringent reviews of several international orphanages, and a few have been selected our partners We are very selective on who we partner with, as we provide these orphanages with significant funding for specific projects Over the last five years, Touching Heart has held an annual Golf Tournament through which corporate sponsors can directly support children in need both locally and globally Some of the significant global projects we have supported in 2015 included built a chicken farm at an orphanage in Kenya, purchased a computer lab in Sierra Leone orphanage, opened a medical clinic in Uganda, provided wind generator in Tanzania orphanage, and built revenue generating bakery in Zambia school Touching Heart helps children in need right here in our area as well Local projects and programs in the past have included assembling lunches for the homeless in Reston, VA, organizing a Summer Fun Fair and Winter Holiday Party for Fairfax County foster children and their families, and providing backpacks fully stocked with school supplies to Fairfax County foster children
