28 Engaging Community As a network of more than 325 partner organizations (businesses, nonprofit organizations, faith communities, educational institutions, and local government) and hundreds of individual volunteers, the Coalition provided grassroots leadership, inspiration, resources, and opportunities for collaboration in working on sustainability issues The Coalition encouraged community involvement and interaction by inviting the entire community to its quarterly meetings, where attendees had the opportunity to network and share information about sustainability issues, and numerous presenters among the partner organizations and 12 action teams talked about their sustainability accomplishments In March 2015 the Coalition hosted its annual Sustainability Fair and Town Hall event, which was attended by more than 500 people, to continue highlighting the sustainability efforts of the community and to prompt discussions among the participants in small groups on local sustainability matters The Sustainability Fair featured local food, lively music, and more than 50 hands-on sustainability exhibits Featured speakers at the Town Hall event included keynoter Sean McGuire (whose topic was "Ensuring Livability & Well-Being for Corvallis"), as well as Julie Williams of Seeds for the Sol (a local nonprofit providing zero-interest loans to individuals for solar installations on their residences), and Christine Dashiell of the Corvallis Families Gift Economy (a group that organizes clothing and household items swaps several times a year) (Grants \$ 0) If this amount includes foreign grants, check here . . . ☐		28a	8,020
29 Fostering a Healthy Local Food System, Acting on Climate Change, and Promoting Economic Vitality With a goal to encourage more families and young people to connect with our local farms and the products they offer, the Food Action Team led a local event on National Food Day that featured a community Apple Crunch and distribution of free Farmers' Market tokens to 150 children, and also coordinated the annual Local Eats Week featuring local ingredients prepared by chefs at 14 Corvallis restaurants as part of the "Eat 40% Local" campaign In addition, the team distributed the latest edition of the Corvallis Garden Resource Guide to 500 current and prospective gardeners The Energy Action Team led the Coalition to partner with the Corvallis Environmental Center's Energize Corvallis project to launch "Take Charge Corvallis" - the local initiative to compete for the \$5 million Georgetown University Energy Prize, the first year of the 2-year competition focused on supporting energy-saving actions at home, installing free LEDs, reaching out to rental property owners, and promoting heat pump water heaters The Economic Vitality Action Team partnered with Hatch Oregon and the Willamette Innovators Network to sponsor workshops and Meet-Ups focused on local investing through Oregon's new Community Public Offerings The Coalition also co-sponsored the annual Buy Local First Day, Holiday Contest, and Business of the Week program (Grants \$ 0) If this amount includes foreign grants, check here . . . ☐		29a	2,617
