Spiritual Growth: Producing a 24-hour, spiritually-engaging, non-commercial radio format that fosters spiritual growth in the lives of individual listeners, leveraging both Christ-centered music and practical Bible teaching. The resulting spiritual growth in each individual is foundational to our purpose of advancing the gospel of Jesus Christ. There were over 1,000 written interactions with listeners, including prayer requests, and impact stories. Over 900 people received a free "Compassion" book after committing to read it and apply it in their life. Twenty compelling Bible teaching programs and short features brought spiritual perspective on marriage, parenting, finances and life challenges. 14 struggling marriages were given scholarships to attend a marriage enrichment seminar. 11 military couples were given scholarships plus hotel and food gifts to send them to a marriage seminar. About 1000 listeners received our music advisory team survey each month, providing valuable feedback to keep our song list relevant to listener preferences. Online listening exceeded 450,000 hours and our informative website received approximately 4500 web users each month.

Connection: Fostering cooperation among churches and faith-based ministries by serving as a common connection point for information. Relationships are built with leadership of churches and faith-based ministries and information is gathered about their activities and then communicated through our website, on-air announcements and produced spots. Approximately 150 Nebraska churches, ministries and individuals had the opportunity to share highlights of God's work through ministry spotlights, morning conversations and other on-air segments. Twenty ministries recorded one-minute impact stories which aired in daily rotations. Many mission trips were highlighted and supported with prayer. Listeners connected with us over 2000 times regarding posting community events, on-air celebration announcements, and interactive contests. 5,500 people received our monthly newsletter, keeping them connected to local ministry opportunities and events. About 5400 received regular social media updates.

Mobilization: Maximizing evangelistic opportunities by mobilizing listeners to new levels of spiritual advancement across denominational lines. Carefully selected high-impact opportunities and events are heavily promoted in order to call the listener to action. In 2015 some of these action points included over 2200 backpacks being donated for education and outreach in India, 105 couples attending a marriage enrichment conference, 50 families attending informational events on becoming foster parents, several families attending training classes to become foster parents.
