The organization developed and distributed safe water systems to a non-governmental organization, TivaWater, and supported TivaWater's efforts in other countries to educate entities and individuals in safe water systems. In 2015, approximately 2,000 TivaWater home filters were donated to vulnerable families through partnerships with NGO's like Child Fund Uganda and Health Talents International. It is estimated that each point-of-use filter provides clean water for 10 people, so about 20,000 clients received clean water access in 2015. The water filter prevents household waterborne disease which increases quality of life. Dirty water is the #1 killer of children five and under. Additionally, the filters increase family household income as many families spend significant portions of disposable income on charcoal/wood to boil water for drinking. The TivaWater filter replaces the need to boil as it filters the water and is ready to drink.

In 2015, World Water Project continued its financial support and oversight of a poultry farm school, Chicken City Farms, located near Kampala, Uganda. This working farm teaches necessary skills to the workers who will graduate and eventually run their own farms. The sustainable school has trained six young indigenous people to own and operate poultry farms. Additionally, the farm has grown to a capacity of over 15,000 broiler chickens and is the largest employer in the region.

In 2015, World Water Project became involved in the FOCUS Child Project, a program that supports children from the Mulago-Kalerwe slum community in Kampala, Uganda. These children are supported financially through individual sponsorships so that they have the opportunity to attend school and also be provided with their basic needs.
