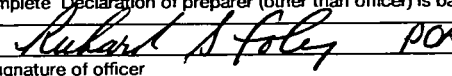

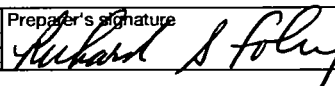

Team Heart works with the Rwanda Minister of Health and citizens of Rwanda to establish a sustainable independent cardiac surgical and medical program in Rwanda. Team Heart and the international partners work with and support the Rwanda Ministry of Health and the Rwandan Heart Foundation in identifying and implementing an improved care delivery system for individuals diagnosed with rheumatic heart disease within the existing health care system. Team Heart performed 17 heart surgeries to treat rheumatic heart disease in Rwanda during 2015. Volunteers for the surgical development and screening trips come from various states and countries and are all employees of academic medical centers whose cardiology and cardiac surgery programs are consistently top rated in the United States.
