	Community Organizing (Outreach and engagement) Throughout the state in 2015 ACCE Action members implemented new organizing programs and won critical policy fights that positively impact the communities we organize in Richmond communities organized to pass Rent Control and just Cause Evictions through the city council, in Los Angeles city and unincorporated county workers fought to win a minimum wage increase giving all workers \$15/hr by 2020, in San Diego parents began an effort to improve school facilities and are advocating for a school bond measure for the sweetwater School District, in Sacramento we began to form rapid response teams to help victims of police misconduct, Oakland worked aggressively to ensure the city council allocated appropriate funding to enforce the recently won minimum wage increase, and San Francisco members have been seeking housing solutions that would end the displacement of the city's black residents, especially in the mission district In addition to these local fights, members from across the state conducted Sacramento and in district lobby visits to push for the passage of a bill that would curtail wage theft, an effort that ended in a victory when SB 588 was signed into law
