The Source provides a venue for long term Ex-Pat workers to stay by helping to provide visas and other services. It also oversees the Ujung Karang, (Coral Reef) Conference Center on the island of Weh (Sabang), Sumatra. They have implemented disaster response training and provide a tangible community development to the people and government of Aceh. The Source also provides basic hygiene and sanitation training through the CWHL (Clean Water for Healthy Living) program to marginalized communities in Aceh and is an umbrella organization for an English Language School.

Indonesia - Aceh Sustainable Peace & Community
To see the people of Aceh enjoy an increasing quality of life having been equipped to help both themselves and their neighbors. Mission is to channel resources to alleviate the suffering of the people of Aceh while empowering local people to achieve sustainable community development. Aceh is the worst affected location as a result of the 2004 tsunami, with massive loss of life and destruction of infrastructure. The people of Aceh have also suffered during armed conflict that lasted more than 30 years. Methodology includes establishing pilot projects of plantation and nurseries for cash crops and animal husbandry which are being used as showroom and training center for agricultural projects in neighboring villages. Serving 450 families, 2000 people.

Indonesia - Aceh Peace & Business Development
To see the people of Aceh enjoy an increasing quality of life having been equipped to help both themselves and their neighbors. Methodology includes establishing pilot projects for animal husbandry which is used to showcase and train people on developing sustainable agricultural businesses. Serving approximately 450 families, 2000 people.
