

We provide free and low cost veterinary services to low income pet owners. This is the major part of our efforts at this time. In 2015 we treated 4,882 low income household pets. We also provided free veterinary services for NYC Animal Control animals at the rate of 12 % of our net income. In addition we provided free services to low income pet parents at the rate of 18.6 % of our net income, and 6.5 % of our gross program revenue. Together, our total free services amounted to 30.6 % of our net revenue and 10.7 % of our gross revenue in 2015. As a result hundreds of NYC Animal Control animals were treated for free, including expensive surgeries, which made them adoptable into new homes rather than each animal costing NY City \$ 250-300 to intake.
