In 2015, The Clagett Regatta hired 5 coaches to coach 50 sailors in 3 different classes of boats. There were 22 on water volunteers handling the Race Committee and safety/medical positions. There were 5 members of the Jury who spent time on the water and additional coaches and speakers who gave numerous on-land clinic talks. The Clagett consisted of one clinic day and 3 days of racing. Each of the 3 classes sailed 7 races for a total of 27 races for 3 classes over 3 days. Almost half of the teams that competed in the 2015 Clagett went on to compete at the International level of racing.
