Student Sponsorship Program The goal of the student sponsorship program is to provide school fees for Kenyan children to be able to attend secondary and post-secondary school through connection with sponsors in developed nations As of December 2015 there were 225 actively sponsored students (139 Male, 86 Female) Of these 134 were secondary school students and 91 were poly tech/trade school, college, and university students Total sponsors 85 individuals, 67 families, 16 other groups (schools, rotary clubs, etc) 51 of these were new sponsors Upon graduating from secondary school, all graduates participate in 6-9 months of volunteer work in various community institutions, i.e schools, libraries, health dispensaries

Infrastructure Program The goal of the Infrastructure Program is to further the effective impact of our education activities through provision of books and facility enhancements This includes the provision of textbooks and reading books at primary and secondary school libraries and the Taru Community Library In 2015 infrastructure funds were also provided for the initial phases of the construction of a community education and resource center in support of our goal of providing ongoing education for children and adults in the village area These funds have been collected over a 3-year time period
