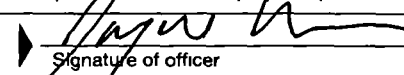

28 Athletic Training. Our mission statement is born from our ability to provide athletic training to our members. Practice facilities and training are provided as a service to our members in the sport of roller derby. Both on skates and off skates athletic training is provided.

In 2015, 73 league members benefited from FoCo Roller Derby athletic training services. There are four practices per week on average; it is estimated that there are 176 opportunities for practice per year from January through December.

All of our members benefit by gaining exposure to the sport and our roller derby community.

29 Event Production. FoCo Roller Derby holds events open to the public called 'bouts.' These bouts, or games, provide opportunity for our members to exhibit skills gained during member practice, and spectators to watch athletic roller derby competition.

On average, 20 members participate in the event and 110 spectators purchase tickets for a bout. In 2015, 1095 spectators attended ten (10) bouts from February through November. Holding these events is key to our mission statement and allows us to generate funds necessary to pay for venue rental used for practices.

30 Strategic Planning Retreat. The annual strategic planning event is a weekend-long member gathering and focus group. Our members participate in goal-focused sessions that include organization-wide goal setting, defining committee objectives, assigning member roles and responsibilities, selecting non-profit partners, drafting teams, planning event schedules, and team building exercises. This planning meeting and its results drive the focus of our upcoming year and athletic season. Twenty-five members attended in 2015.
