Direct Financial Assistance to Individuals Going Through Cancer Treatment and Recovery

One of our primary current program goals is to provide financial assistance to individuals undergoing treatment for breast cancer or other forms of cancer. Seymour Pink believes that by easing the burden of debt, the breast cancer patient can focus on recovery. We have a formal application and Board review process in place, and all distribution information is carefully tracked and documented. Please see Attached Schedule O for greater detail on this program

Grants to Yale New Haven Hospital Smilow Cancer Center

Seymour Pink presented a check for \$10,000 to be used to support 2 programs associated with the Smilow Breast Cancer Center. Five thousand dollars was given to support Breast Patient Infertility Counseling. This is an initiative which would allow financially challenged young patients to participate in post-chemotherapy fertility counseling and treatment. This would allow women to review their treatments for breast cancer with proper knowledge of the impacts of such options on child bearing after treatment.

Five thousand dollars was given in support of Dr. Andrea Siber, who works with financially challenged breast cancer patients from the Derby, CT (her primary office) and surrounding areas. Such patients often need additional support when undergoing treatment. For many, the treatment regime and costs forces them into a situation where ongoing day to day needs cannot be met - due to no insurance or very high deductible insurance and inability to work for extended periods of time

Comfort Kit Baskets Donated to Individuals Fighting Cancer

This program has been one of our mainstays since our original formation. It involves the procurement, assembly and donation of "comfort kit" baskets to individuals who are undergoing treatment for breast cancer. Such baskets include unique food, personal hygiene, clothing and related items that are specially focused on the needs of treating cancer patients, particularly those undergoing chemotherapy. Kits include items such as oral hygiene products, teas and ginger for nausea, warm socks, a sleep cap and more.
