Objective: To change attitudes towards farming and encourage adoption of intensive farming practices in the country of Niger. The program targets mothers in the community and students in the local schools. Students receive a combination of classroom and experiential learning. The mothers participate in profitable and self-sustaining agribusiness ventures. Program design was completed in 2011. A four year field test started in 2012. This project has been included in all 990 reporting years. 2015 Accomplishments: Refined the model to increase effectiveness, reduce cost, and simplify implementation. Preparation being made to open new showcase site - 3x larger than previous locations - incorporating all the

Objective: A test model to provide affordable extension agent services to rural farmers in Africa. The Lead Farmers Program organizes 35-50 farmers into associations. Each association elects a "lead farmer" to work directly with an extension agent to apply best agricultural and business practices to maximize farm income. The "lead farmer" is responsible for sharing those practices and encouraging their adoption with all members of the association. The program is being tested with smallholder farmers in Mayange, Rwanda in partnership with the Millennium Villages Project. The project was new in 2013 and part of this report into 2014 and 2015.

4c (Code) (Expenses \$ **20,000** including grants of \$ **20,000**) (Revenue \$)**SONGHAU WOMEN'S CAPITAL FUND**

Objective: To provide low interest loans to women graduates of the Songhai Centre to start up their own farming ventures. The goal is to showcase what talented and motivated women can do when given the training and opportunity. They become role models for others to follow, increasing female enrollment in the prestigious Songhai Centre and changing the perceived role of women in society. The program was listed in Form 990 in years 2011 through 2015.

2015 Accomplishments: The year 2015 showed excellent results in increasing women's enrollment: +50% across all 13 campuses; +600% at the original Porto Novo campus. Mixed performance on business ventures will require new
