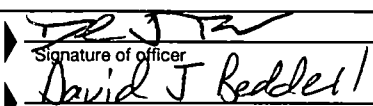

Grant paid of \$64,645.17 break down into two categories. Hardship grants which are awarded to families that are suffering from financial hardship due to breast cancer treatment that total \$62,645.17. Grant sizes are determined based on financial needs and set based on actual expense being incurred by the family. Grants ranged from \$200 to \$4,850. The second category is a yearly scholarship that is awarded to a student that has a parent or guardian affected by breast cancer. Each year a new student is awarded a 4 year renewable \$500.00 scholarship. Each year a total of \$2,000 in scholarship money is awarded 1 new scholarship and 3 renewals from previous winners

Other expenses of \$21,802 are all fundraising expenses from two main events that are used to raise the vast majority of the foundation's revenue. A charity ball with a silent auction that takes place in the winter (generally Q1) which accounts for \$18,315. And a 5K run/walk race that takes place in the summer (generally Q3) which accounts for \$3,487.

Total Liabilities of \$2,500 are from awarded scholarships. Each year a scholarship is awarded and it is a renewable four year scholarship the pending payments are accounted for as liabilities
