In 2015 Supporting Kids Foundation (SKF) provided over \$191,000 in assistance to 86 families with 67 of those families receiving assistance for the first time. This all volunteer organization receives most of its referrals from the Children's Mercy Hospital Network and the University of Kansas Hospital system. SKF helps families with children in the hospital to cover such expenses as rent and mortgage payments, utility bills, car repairs and gasoline. In the most unfortunate cases SKF has paid for a child's funeral expenses. SKF raises funds to help families in need to cover day to day expenses so they can focus on their child's health rather their financial short falls. Since its inception, SKF has helped 263 families by giving them over \$504,000.
