Heshima Kenya specializes in identifying and protecting unaccompanied and separated refugee children and youth, especially girls, young women and their children living in Nairobi, Kenya. By providing shelter, education and community outreach services, Heshima Kenya is empowering this population to live healthy lives. With long term support these girls and young women become catalysts for strengthening networks creating sustainable change within the local and global communities. In 2014, Heshoima Kenya will provide 80 girls and young women with access to education and livelihood support through its Girls' Empowerment Project. Our \$5,000 grant will support this program, which offers the holistic education and skills these girls and young women need to empower them to reach their potential.

Lift Up Africa is a U.S.-based nonprofit with an extensive network of partners and projects in East Africa. Its mission is to connect knowledge, resources and needs. The HELGA rescue center provides a safe haven for rescued girls from early marriage, to ensure retention and participation in their education and reconciliation with their families. The 40 girls at HELGA will not only benefit from gaining their education and escaping oppression, the whole community will become enriched through the new educated adults that have completed their studies through a sustainable rescue center. Our \$5,000 grant supports 10 young girls at HELGA for a year.
