donated by community citizens, local grocery stores and a local  
dairy farm, collected and distributed by PORCH volunteers.

Expenses include this same value plus \$117,401 received as general  
cash donations used to purchase produce and other groceries also  
distributed to the recipient families.

Donations to local food pantries program - Groceries are provided to

Expenses include this same value plus \$0 received as general  
cash donations used to purchase produce and other groceries also
