Project Vision Hawaii's "Better Vision for the Keiki" project targets children specifically with vision and school readiness screenings. We have been able to provide over 8,000 children with these screenings and hold wellness events that have reached over 14,000 people statewide. The program is a Title 1 public school and preschool initiative for low-income children designed to detect vision, hearing, obesity and learning disability problems.

Our "Better Vision for a Better Life" for the underprivileged project provides comprehensive eye screening, prescription and reading glasses, and protective sunglasses for the uninsured and underinsured individuals, many who are homeless or very low-income seniors. We have reached over 1,000 people, providing prescription glasses and follow-up care for those who need our services most.
