WE FEED A QUALITY AND BALANCED MEAL FOR LUNCH AND DINNER. IN ADDITION WE FEED AROUND 3,000 ON THANKSGIVING DAY, INVITING THEM TO BE OUR GUESTS AND EAT IN THE RESTAURANT. WE PROVIDE OVER 200 WEEKLY MEALS TO HICKORY GROVE HOUSING AND HOSKINS PARK MINISTRY. IN AUGUST, WE STARTED SERVING 150 HOT DOGS EVERY FRIDAY NIGHT AS PART OF OUR STREET MINISTRY TO THE HOMELESS. WE HAVE SERVED MEALS TO A CHILD'S PLACE, FREEDOM SCHOOL AND OTHER LOCAL MINISTRIES AS THE NEEDS ARISE. THE KING'S KITCHEN RESTORATION JOB TRAINING PROGRAMAS MENTIONED IN OUR MISSION STATEMENT ABOVE, THE RESTORATION PROGRAM'S GOAL IS TO TRAIN PEOPLE IN THE TRADES OF THE RESTAURANT INDUSTRY. WHAT IS UNIQUE ABOUT OUR PROGRAM FROM OTHERS IN THE AREA IS THE REAL WORLD EXPERIENCE COMBINED WITH A CHRISTIAN MINISTRY. RESTORING PLACE CHURCH AND THE CHARLOTTE MECKLENBURG DREAM CENTER UNDERWRITE THE MINISTRY FOR ALL TRAINING PROGRAMS AND BIBLE STUDIES IN ADDITION TO MENTORING THE PARTICIPANTS.
