The Battery Electric Car was also used to promote local adoption of the public electric vehicle charging stations and for display and ride and drive events at public gatherings, in the Great Smoky Mountains National Park in conjunction with opening the first-ever DC Fast Chargers in any National Park, and at our Educational Center. Working on placing new display Electric Vehicles with multiple science and children's museums in the United States. Worked with the Smithsonian Institute Museum of American History to coordinate visits for Electric Vehicle Manufacturing in the United States exhibit. Sponsored National Drive Electric Week event at The Island in Pigeon Forge, TN. Installed new Tesla Destination Charging stations in Tennessee, North Carolina and Georgia.
