	AS AN ACCREDITED STATE CHAPTER OF THE NATIONAL CHILDREN'S ALLIANCE (NCA), THE VT CHILDREN'S ALLIANCE (VCA) CONTINUED TO GROW IN ITS ABILITY TO SUPPORT ITS 13 MEMBER CHILD ADVOCACY CENTERS (CACs). NOTABLY, IN 2015 VCA ADDED A NEW MEMBER PROGRAM WHEN THE ONE COUNTY THAT HAD NOT BEEN SERVED BY A CAC ESTABLISHED ONE. THE VCA CONTINUED ITS WORK TO STRENGTHEN THE SYSTEM OF CARE FOR VICTIMS OF CHILD ABUSE BY CONTRACTING WITH MENTAL HEALTH PROVIDERS ACROSS VERMONT, WHO IN TURN FACILITATE MONTHLY PEER SUPPORT AND CONSULTATION GROUPS FOR PROVIDERS DOING THIS CHALLENGING WORK. THE VCA HOSTED SEVERAL TRAININGS FOR ITS MEMBERSHIP THAT WERE OFFERED AT NO CHARGE AND DESIGNED TO ENHANCE AND SUPPORT THE CAPACITY OF EACH PROGRAM TO SERVE ITS LOCAL COMMUNITY. IN THE SPRING OF 2015, MEMBER PROGRAM STAFF PARTICIPATED IN A TWO DAY TRAINING DESIGNED TO PROVIDE THEM WITH MASTERY OF CHILD ABUSE PREVENTION CURRICULA-THEREBY GIVING THEM THE TOOLS TO PROVIDE THIS EDUCATION AND OUTREACH TO THEIR LOCAL SCHOOLS AND COMMUNITIES. OUR MEMBER PROGRAMS NOW HAVE THE REQUISITE TRAINING TO REACH EARLY ELEMENTARY, ELEMENTARY AND MIDDLE SCHOOL AGE STUDENTS, SCHOOL STAFF AND CARETAKERS. IN NOVEMBER 2015, THE VCA HOSTED A THREE DAY TRAINING PRESENTED BY STAFF FROM THE NATIONAL CENTER FOR PROSECUTION OF CHILD ABUSE ON RESPONDING TO CHILD PHYSICAL ABUSE. THERE WERE APPROXIMATELY 80 PARTICIPANTS WHO HERALDED FROM ALL ACROSS OUR STATE. IN DECEMBER OF 2015, THE VCA HOSTED ANOTHER TRAINING FOR ITS MEMBERSHIP FOCUSED ON LEGAL ISSUES IMPACTING CHILDREN'S ADVOCACY CENTERS. THE VCA ALSO ENGAGED IN TWO PUBLIC AWARENESS/SOCIAL MEDIA CAMPAIGNS INTENDED TO ENHANCE THE PUBLIC'S KNOWLEDGE AND AWARENESS OF CHILD ABUSE AND SEXUAL VIOLENCE. FINALLY, WE CONTINUED TO OVERSEE THE OUTCOME MEASUREMENT SYSTEM (OMS) THROUGHOUT VERMONT, THE OMS ENABLES OUR PROGRAMS TO OBTAIN VALUABLE FEEDBACK FROM THEIR CLIENTS AND PARTNERS ABOUT AREAS OF STRENGTH AS WELL AS AREAS OF CHALLENGE.
