The WISER boarding secondary school provides all education, room and board, extracurricular activities and health care to 120 disadvantaged girls and AIDS orphans every year. The WISER Bridge primary school program provided after school enrichment programs to over 700 students as well as teacher training to 30 primary school teachers throughout the academic year.

The WISER NGO hosted students from Duke University who, among other projects, conducted research on the impact of our clean water system on community health and the challenges to expanding the system to serve more people
