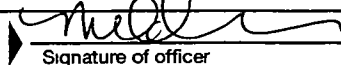

Part I, #10 (Grants and Similar Amounts Paid)

A total of \$41,776.76 was paid out to benefit children associated with The Rose of Sharon orphanages in Zimbabwe. This amount included scholarship for 2 students and sponsorship of 60+ children to include food, shelter, clinic treatments, medications, school supplies, school uniforms, and school fees/tuitions for approximately 65 children. Funds were also used to establish the Zim Baby Project - an investment in our Zimbabwe orphanage partner to set up a nursery for the influx of new babies and toddlers admitted to the program by their local Social Welfare Services.

A total of \$12,301.19 was paid for other expenses including:

1. Online Transaction Fees (to process Credit and Debit Card Donations) \$2,626.85

2. Donation Management (Kindful Company) \$778.64

3. IRS Tax Payments \$295.51

4. Emart Payroll Processor \$105.00 (due annually)

5. International Missions Travel for 3 missionaries (These funds were raised by the missionaries) \$6,467.45

6. Domestic Travel for Speaking and Networking Engagements \$121.84

7. Board Meetings (space rental and food) \$178.89

8. Local Networking Events/Meetings \$25.33

9. Website Hosting (IcgLink) \$150.00

10. Computer technology and equipment \$1,300.00

11. Office Supplies \$251.68

Part I, #20 (Changes in net assets or fund balances)

I've indicated a change in the amount of \$-2,565.53. This was a failure to document cash expenditures in Zimbabwe for our orphanage partner during 3 visits in 2014. These were combined givings and purchases including education awards, travel excursion for the children to visit The Great Zimbabwe (room & board & transportation). This also included bus fares for approximately 12 children to visit the rural area where they were born - near the border of Mozambique. Funds also included road tolls in Zimbabwe, fuel and an auto mechanic to make a repair to the bus. These expenditures were tallied by hand because receipts were not available - and therefore accidentally forgotten in the accounting until the balance error was noticed.
