The work done during an estimated 2783 of these volunteered hours required specific medical or nursing training. Given that our organization relies heavily on the service and expertise of our dedicated volunteers, many of whom provided us with services (including the development of educational materials, translation, web development, etc.) that would otherwise have needed to be purchased, and because the value of donated services is not taken into account in Form 990, the figure on line 32 is far lower than it would be if the value of donated time was taken into account. We therefore also include here the estimated total value of volunteer time and unreimbursed expenses in 2015, in order to provide a more accurate picture of the small percentage of our true "assets" that we actually devote to our non-program expenses. In 2015, we estimate that the value of volunteer time and services was \$308,403. (This figure is a conservative estimate based on the Independent Sector's 2014 estimated value of volunteer time of \$22.55 per hour for all volunteer hours not requiring special skills, the Bureau of Labor Statistics' 2014 mean hourly wage data for volunteer hours requiring specialized skills, and out-of-pocket expense, unreimbursed travel costs incurred by volunteers traveling to Haiti on EqualHealth business.)
