The POP Market is a year-round, wholesale market that connects small to mid-scale farmers with community organizations. Our goal is to help hard-working farm families (especially beginning farmers, female farmers and farmers of color) make a decent living, while making nutritious, local food available for a broader range of people who want it. Other initiatives include Community Food Shares (a group produce buying club) and FVRx (a Fruit and Vegetable Prescription program to patients struggling with food insecurity and diet-related chronic illness).

4b (Code:) (Expenses \$ 102,798 including grants of \$) (Revenue \$)

Farmer Foodshare volunteers run tables at Farmers Markets where farmers can donate local food for people in need in their own area. Shoppers help, too by donating fresh produce bought at the market or cash to purchase food from the farmers. All this fresh, healthy food is then shared with local agencies serving neighbors in need.

Food Ambassadors trained volunteers who go to community sites to share how to store and prepare fresh produce in ways that are both economical and delicious. Additionally, we've put together Fruit and Veggies Fact Sheets, and a collection of simple recipes. Other Food Ambassador initiatives include Community Meals, where farmers, recipients, and volunteers build community around the table.
