In 2015, we completed 26 home repair projects for 22 homeowners We completed 2 roof replacements We helped 5 homeowners with projects that improved energy efficiency, 9 homeowners received home repairs to promote safety and healthy homes, and 10 homeowners received handyman services such as painting, structural repairs etc (Continued on Schedule O)Rebuilding Together focuses on helping low income families with an emphasis on helping Veterans, elderly and people living with a disability Our goal is to create safe and healthy homes for all low income homeowners Of the homeowners we helped in 2015 7 were over 65 years of age, 8 live with a disability, and 7 of are Veterans or widows of Veterans Most of the homeowners are living on Social Security as their only source of income making it difficult to afford these needed repairs Some homeowners were classified in more than one of the 3 three emphasis areas In addition to the revenues and expenses reported in Parts VIII and IX we are supported by several volunteers that assist in accomplishing our program In 2015 we were able to reduce our expenses by \$31,129 due to \$23,929 in labor donations and \$7,200 in in-kind rent
