Iringa Hope Joint SACCOS: This is a SACCOS whose members are registered village SACCOS (Savings and Credit Cooperative Societies under Tanzanian law). This acts like a micro-finance bank supporting the network of Iringa Hope Village SACCOS. Annual loans augment the village SACCOS capital to enable making more loans to their members. Interest is charged which provides the Joint SACCOS with income, part of which is used to support the operating costs of the Iringa University Micro-Finance Institute. Our goal is to build this facility to the point where it will fully support the Institute's annual operating budget. There are now 27 village SACCOS members in the Joint SACCOS.

4b (Code) (Expenses \$ 24,523. including grants of \$ 24,500.) (Revenue \$ 0.)
Micro-Finance Institute Building: Supported by a 2014 grant from the Peter J. King Family Foundation, work started in 2014 on a building on the Iringa University campus to house the Iringa Hope Joint SACCOS and the Micro-Finance Institute staff. The staff has now grown to 4 and the office space previously provided by the University was no longer adequate. The building was completed in 2015.

4c (Code) (Expenses \$ 18,708. including grants of \$ 17,000.) (Revenue \$ 0.)
Support of the University Iringa Micro-Finance Institute: grant funds were provided to support the operating budget of the Institute including costs for the two training sessions put on each year for the officers and directors of the village SACCOS. The Institute staff work with new villages helping them through the process of setting up a village SACCOS, provides orientation and training to prospective members and officers, and meets in each village with established SACCOS members.
