Although the tax filing deadline is May 15, it fell on a Sunday for 2016. According to IRS filing requirements, if a due date falls on a Saturday, Sunday, or legal holiday, the due date is delayed until the next business day. Thus annual return for the 2015 tax filing year for Cheza Nami is not late.
