Ratio Chnsti's University Apologetics Program. Ratio Christi grew to over 150 chapters in 2015. The average chapter serves anywhere from 10 to 20 students, giving us a reach of over 1,000 to 2,000 students who participate in weekly meetings on campus. We also held public events at many of these campuses, reaching as many as 200 to 300 or more at each event. Ratio Christi also continued to redesign our web site, making our reach worldwide. We implemented a strategic plan for long term financial stability, which includes supported missionary apologists on campuses. We have relationships with ten major seminaries and dozens of apologetics ministries in the U.S.
