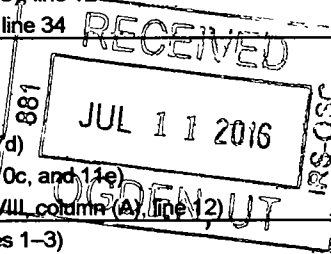

During 2015 grants were used for constructing a greenhouse made of recycled two liter bottles and PVC pipes, creating a STEAM lab, improving third grade reading achievement, setting up LEGOs in Motion to help students become interested in engineering, purchasing LittleBits electrical invention kits and Sphero and Ollie robots, reinforcing math concepts, creating a de-constructed writing lab, creating a 3-D printer design lab, purchasing Newton's Toy Box, creating Magic Book Bus Literacy Project, building STEM through robotics, creating a Tech Theatre Laboratory, etc.
