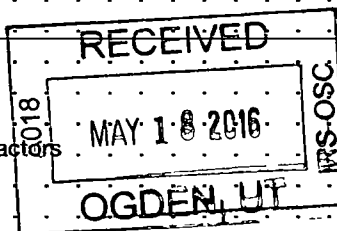



Part 1, Line 10: Grants made in 2015 totaled \$107,150. The grants are all made to the Heather Chimoga Orphan center in Zimbabwe. Grants are generally made via wire transfer to the bank account of HCOC in Zimbabwe. ZMP has significant influence over how the funds are distributed in Zimbabwe, but it does not have signing authority over the local bank account. Thus grants are not made directly to vendors, schools, workers etc.

Part 1, Line 16: The "other" expenses in 2014 were all for a local bicycle event (jerseys, website etc.). This fund raiser only covered its costs through the fees of the riders - but it produced about \$48,000 of donations to the organization from individuals supporting the riders.

Part 11, Line 26: The amount on this line (\$706) has been promised to a particular project, but not spent by the end of the year. In order to keep track of this (while still using cash accounting) we account for it as a liability as it will be spent for as promised in 2016.
