IN 2015, ACAM AWARDED 60 GRANTS TO COMMUNITY ASSISTANCE MINISTRIES IN THE GREATER HOUSTON AREA. ACAM AWARDED 23 GRANTS FOR ORGANIZATIONAL AND PROFESSIONAL DEVELOPMENT PROMOTING SOUND PRACTICES IN NONPROFIT OPERATIONS AND PROGRAMMING, AND SUPPORTING ORGANIZATIONAL PLAN IMPLEMENTATION THROUGH TRAINING AND CONSULTING STIPENDS AND DIRECT GRANTS. ANOTHER 11 GRANTS WERE AWARDED TO MEMBERS FOR BUILDING INFRASTRUCTURE IN ORDER TO ACHIEVE BETTER OUTCOMES AND EMPLOY ENHANCED SERVICE MODELS. FOUR GRANTS WERE AWARDED TO IMPROVE PUBLIC BENEFITS ACCESS FOR LOW-INCOME FAMILIES. ACAM ALSO CONTINUED THE EMERGENCY SOLUTIONS COLLABORATIVE INITIATIVE WHICH RESULTED IN FOUR SIZABLE GRANTS (AND THREE SMALLER GRANTS) TO MINISTRIES STRENGTHENING THEIR HOMELESSNESS PREVENTION AND INTERVENTION (HP&I) PROGRAMS IN 2015-2016. ANOTHER 12 GRANTS WERE AWARDED FOR GRANTING HOLIDAY TOYS TO LOW-INCOME CHILDREN. THREE GRANTS WERE MADE TO ASSIST MINISTRIES IN DISASTER RELIEF AND RECOVERY EFFORTS.
