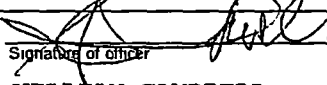

Rapha Academy Fresh Start Childcare Center is a Christian preschool and aftercare program for infants beginning at 6 weeks through children 4 years of age. Weekday hours are 6:00 AM to midnight, and Saturday hours are 6:00 AM to 6:00 PM. 80 children received services in 2015. A summer program that included 8 weeks of recreational and educational field trips as well as an educational boot camp was included. 14 TANEF Summer Program workers provided 11,340 hours of service; 2 volunteers provided 144 hours of office work, childcare assistance and maintenance; and the Executive Director provided 1,500 hours of service at no charge, for a total of 12,984 hours.
